Checking the validity of a certificate using the OEKO-TEX® **Label Check**

1. Go to the Label Check on the **OEKO-TEX® website**.

2. Enter the **certificate number** to be checked.
3. Press 'check'.
4. The result can be either **valid**, **expired** or **withdrawn**. These 3 cases will be shown on the next slides.



Raw **yarns** made of 100 % cotton (provenience India).

Example certificate scope for fabrics

Woven and knitted **fabrics** made of 100 % cotton, 100 % viscose and their mixtures, raw white, bleached white, reactive yarn dyed, reactive solid dyed.

Example certificate for components/accessories

Metal snap button, prong button and **eyelet** made of copper, electroplated in colour nickel, light nickel, dark nickel, antique brass or painted.

Product class

There are **four** product classes:

- Product class I: **for babies** and toddlers up to 3 years of age
- Product class II: for articles **with skin contact**
- Product class III: for articles **without skin contact**
- Product class IV: for **home textiles** etc.

The lower the number, the stricter the limits. It is also possible to apply for a lower product class for the article.
